SMI Dust and Silica Warning

Using this equipment generates dust, this dust may contain Grinding/cutting/drilling particles from masonry, concrete, metal and other materials, mists and fumes containing chemicals known to cause serious or fatal injury or illness, such as respiratory disease, cancer, birth defects or other reproductive harm. If you are unfamiliar with the risks associated with the particular process and/or material being cut or the composition of the tool being used, review the material safety data sheets and/or consult your employer, the manufacturers/suppliers, governmental agencies such as OSHA and NIOSH and other sources on hazardous materials. California and some other authorities, for instance, have published lists of substances known to cause cancer, reproductive toxicity, or other harmful effects. Control dust, mist and fumes at the source where possible. In this regard use good work practices and follow the recommendations of the manufacturers/suppliers, OSHA/NIOSH, and occupational and trade associations. Water should be used for dust suppression when wet grinding/cutting/drilling is feasible. When the hazards from inhalation of dust, mists and fumes cannot be eliminated, the operator and any bystanders should always wear a respirator approved by NIOSH/MSHA for the material being used.

Grinding/cutting/drilling of masonry, concrete and other materials with silica in their composition may give off dust or mists containing crystalline silica. Silica is a basic component of sand, quartz, brick clay, granite and numerous other minerals and rocks. Repeated and/or substantial inhalation of airborne crystalline silica can cause serious or fatal respiratory diseases, including silicosis. In addition, California and some other authorities have listed respirable crystalline silica as a substance known to cause cancer. When grinding/cutting/drilling such materials, always follow the respiratory precautions mentioned above.

IMPORTANT SAFETY RULES TO FOLLOW

1. Maximum towing speed is 45 mph.
2. Always operate mixer on firm, level ground where it cannot be tipped over.
3. Do not put hands, tools, etc., in drum while mixer is operating or engine is running.
4. Do not try to scrape mortar from sides of drum while mixer is operating, or engine is running.
5. Do not clean the mixer while it is operating or engine is running.
6. Always disengage clutch before starting engine.
7. Do not operate machine if guards are not in place and in proper operating condition.
8. Avoid spilling fuel. Do not refuel while engine is running or while smoking.
9. Do not use the mixers to mix anything except mortar or plaster.
10. **THE MIXER MUST BE RETURNED TO RENTAL YARD CLEAN!!! A CLEANING CHARGE WILL APPLY TO ANY MIXER BEING RETURNED WITH MORTAR OR PLASTER STILL IN THE DRUM!!!!!!**

If the person receiving this handout will not be the user of the equipment, forward these instructions to the operator. **IF** there is any doubt as to the operation or safety of the equipment,

DO NOT USE!!! CALL A TOOL SHED IMMEDIATELY!!!
